This is a summary of the annual report for the SEATTLE POLICE RELIEF ASSOCIATION, (Employer Identification No. 91-0403365, Plan No. 502) for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The value of plan assets, after subtracting liabilities of the plan, was \$5,584,207 as of December 31, 2023 compare to \$4,567,165 as of January 1, 2023. During the plan year the plan experienced an increase in its assets of \$1,017,042. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$1,328,498. This income included employee contributions of \$165,636, realized gains of \$7,708 from the sale of assets and earnings from investments of \$1,155,154. Plan expenses were \$311,456. These expenses included \$248,817 in administrative expenses, \$59,500 in benefits paid to participants and beneficiaries and \$3,139 in other expenses.
